We learned a lot and have a list of Frequently Asked Questions (FAQ's) from the first one that will be helpful to those in the second webinar. Be sure to use the test video when it is sent to you, don't wait until the webinar has started and then contact Faye to tell you how to do it.

We will offer these webinars from time to time as you want them and will likely be limited to the first one hundred people to sign up. We intend to keep the numbers low enough so Faye can take care of any questions that might come up and you can get a prompt response.

After the first one, I gave people the opportunity to send in questions and then recorded the answers. Most of the questions sent to me were answered in the webinar. I summed them up and made an hour and ten minute recording which was available for a week.

About all I did was tell you the same thing again. Keep it simple~~don't complicate it!!!! If there is something you don't understand after watching the webinar a few times, then email your question but keep it simple, blunt and to the point. It doesn't require a page of writing to ask a question.

We want this to be an economical way for you to attend the class in your home at your convenience. We planned it this way so you could watch the webinar more than once if you didn't understand something, and you could stop for a break and start again on your schedule. We don't know how to make it any easier than this or give you a better deal so be sure to read and follow directions ahead of time.
